5. The school shall appoint only qualified and eligible staff.

6. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school premises and furniture at its disposal for holding its examinations free of charges if required.

7. The school will spare sufficient teachers, for invigilation purpose at the examinations of the

Board, as may be required.

- 9. The school will provide Laboratories, Library and other facilities as per norms of the Board.

- 13. The school and its records shall be opened for inspection by Director/official of the Board or an authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.
- 14. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.
- 15. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
- 16. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
